WHO ARE WE?

The Open Space Association and the Deep Poverty Network

- To raise awareness about social, economic, and urban problems;
- To build solidarity with groups that have difficulty accessing their rights and needs and are subjected to social exclusion;
- To empower these groups through various activities, supporting their access to public rights and services;
- To reduce the barriers to their entry to fundamental human rights, including education, health, employment, and social security.



VISION AND MISSION

Vision

Eliminating human rights violations and social exclusion caused by poverty.

Mission 1:

To empower people who cannot access their fundamental rights and needs.

Mission 2:

To contribute to the adoption of rights-based and holistic policies.

Mission 3:

To contribute to the elimination of prejudices against poverty and people living in poverty.

DEEP POVERTY

As Deep Poverty Network, we consider poverty a multidimensional phenomenon in which people are prevented from accessing their economic, social, political, and cultural rights and restricting access to their fundamental rights and needs.

We believe that the fight against poverty should be a participatory, open, transparent, and accountable struggle based on rights, belief in solidarity, urgent intervention, and protecting human dignity.

ACTIVITIES

SOLIDARITY

Why solidarity?

In conditions of unequal distribution of resources and the current economic crisis, we believe that people living in deep poverty should be supported by establishing a solidarity-based relationship of equals.

RESEARCH

Why research?

We believe in the impact of the research and advocacy activities we carry out to make it visible that poverty is a violation of rights caused by policies and to contribute to realizing sustainable and preventive policies.

SOCIAL SERVICE AND EMPOWERMENT

Why social service and empowerment?

While showing solidarity with people living in poverty and unable to access their fundamental rights, we believe in supporting people to be empowered to access information, resources, and self-advocacy as rights holders.

ACTIVITIES

CORPORATE DEVELOPMENT

Why corporate development?

As a newly established non-governmental organization, we believe that sustainable activity can only be possible by installing the essential administrative and practical execution/protection mechanisms of the organization.

RESOURCE DEVELOPMENT

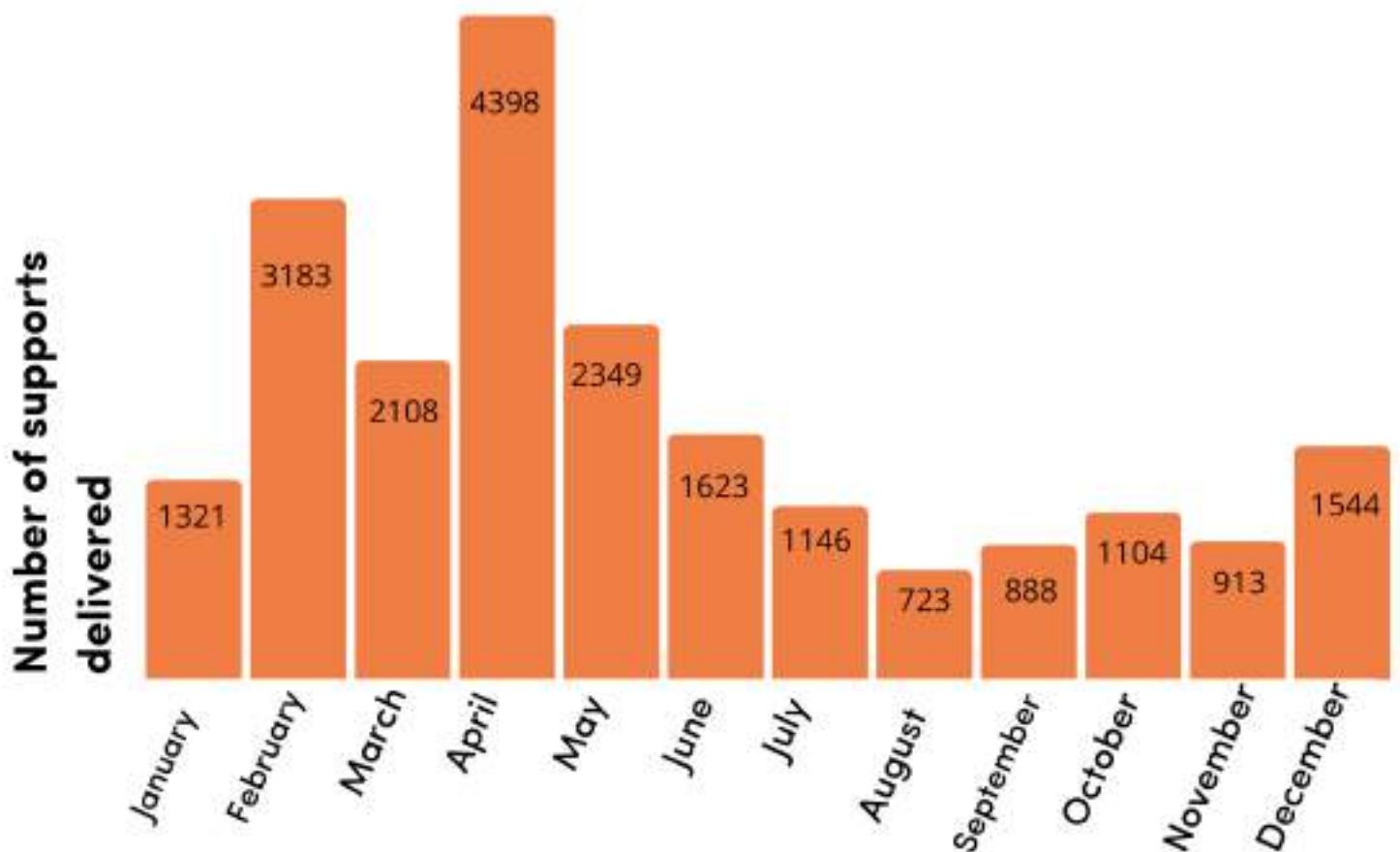
Why resource development?

We care about resource development activities to ensure the sustainability of the organization's support, human resources, and activities, to ensure transparency in the use of donations, and to protect donor rights.

SOLIDARITY

Throughout 2022, we provide support to supported households with a market card with a monthly balance of 520 or 624 liras that can be used in specific markets and can be refilled; as well as stationery, menstrual care products, baby food, hot food, clothing (store card), rent, invoice, medicine, diapers, etc. according to the unique needs of the person.

As of December 2022, 732 households regularly receive grocery card/code support.



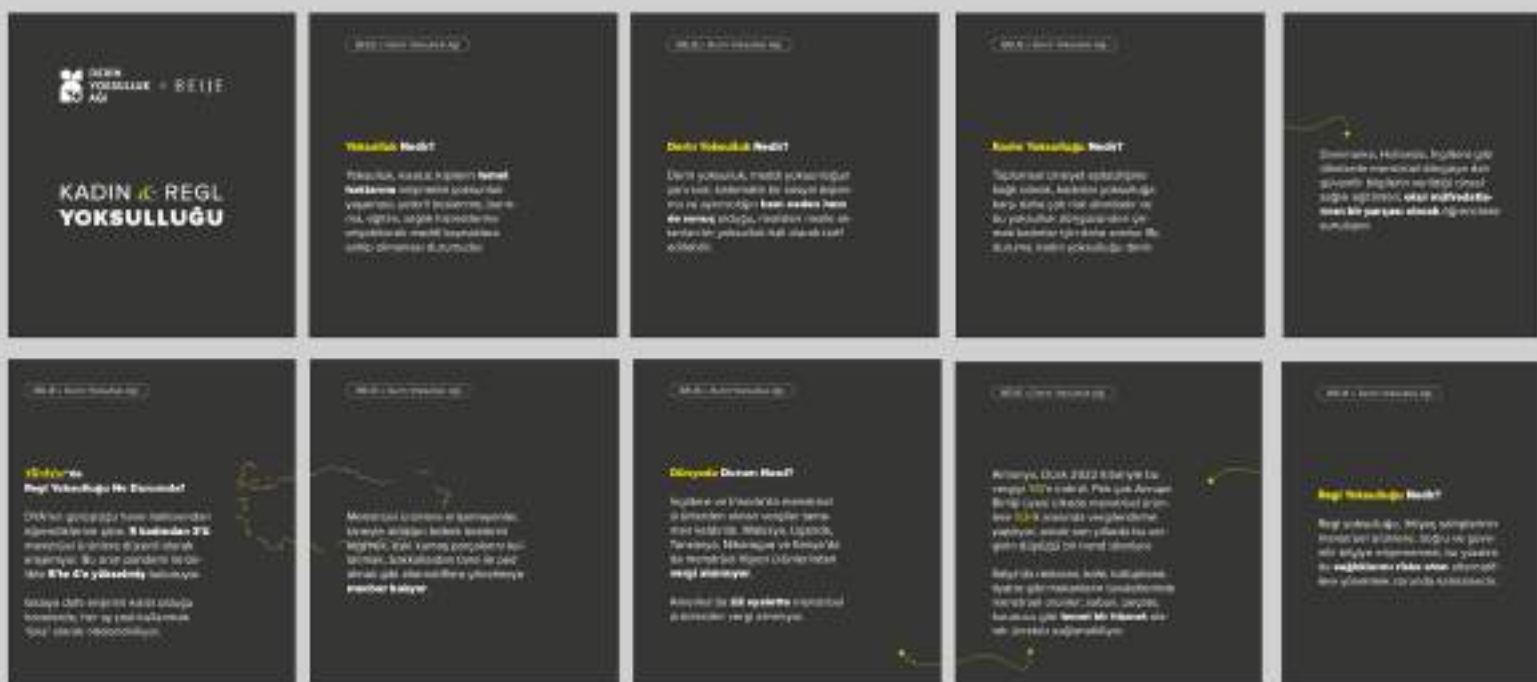
Deep Poverty Network, 2022: Distribution of monthly support delivered.

SOLIDARITY

In collaboration with **BEIJE**, we published informative content to make female and menstrual poverty visible. At the same time, we delivered organic pads from the **BEIJE's** Askıda Ped campaign to girls in primary and secondary schools in the neighborhood where we work.

SOLIDARITY



In cooperation with [TOKTUT'mak Elimizde](#) Association, a total of 16,800 hot meals were distributed in various neighborhoods where we worked.

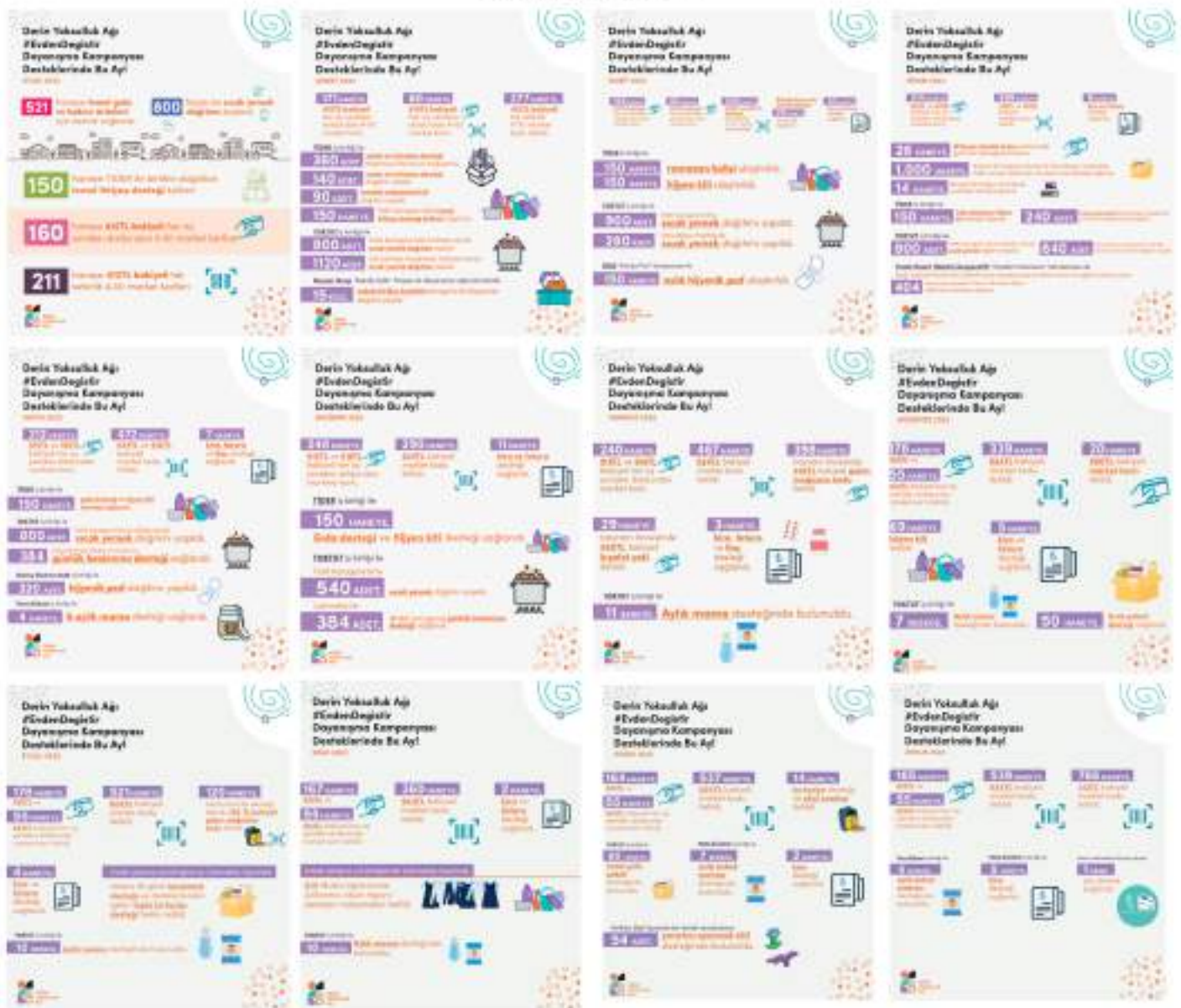
On 23 April 2022, TOKTUT supported the advocacy work we launched to draw attention to the importance of free school feeding programs by opening a hanging lunchbox campaign. This campaign delivered more than 23,000 daily nutritional support to students.

We know that the nutritional status of preschool, primary and secondary school children affects their physical development, health, learning, and cognitive capacity, school attendance, and academic success levels. We continue our advocacy efforts with the call for [#FreeSchoolNutrition](#).



SOLIDARITY

SOLIDARITY

In the neighborhood where we conducted a focused study with the Mobile Food Bank Project, in addition to the work we carried out on individuals' access to basic foodstuffs, we determined the situation regarding the unique needs and basic needs of adults and children in households; we undertook the role of providing information-guidance-follow-up in the process of ensuring individuals' access to fundamental rights and public services.

Through **TIDER** and other collaborations, we tried to meet the demands for basic food, bills, rent, diapers, formula, clothes, shoes, books, stationery, medicines, and furniture. After the regular work in the region, we worked with the nearby [Özyeğin University Sustainability Platform](#) and neighborhood public schools, especially regarding school attendance.

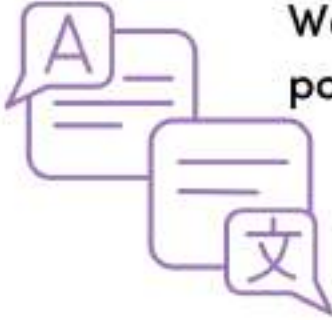
Monitoring the Poverty Agenda in the Media:

We have prepared a series of weekly media scans updated every Monday. News about poverty and poverty and human rights violations published on online media channels can be seen together.

RESEARCH AND ADVOCACY



We have prepared the Monitoring Report: The Poverty Agenda in the Media to analyze what kind of prejudices are fed, how the "poor" is portrayed, what type of discourse strategies are preferred in the news in the media and associated with poverty, and to show good examples.

This report is followed by the two guides we prepared to guide the visuals and narratives used in content that directly or indirectly affects impoverished people.

Guidelines: How to Report Poverty Guidelines: Use of Poverty Visuals

We prepared the guides as the product of a discussion by bringing together the group works with people living in conditions of deep poverty to focus on visibility in the media, a working meeting with members of the press focusing on how to report poverty and the experiences of people working in the Deep Poverty Network.



RESEARCH AND ADVOCACY

International Human Rights Mechanisms

- In October, we participated in the Turkey session of the United Nations Committee on the Rights of the Child in Geneva with other NGOs that reported to the United Nations Committee on the Rights of the Child and presented on child poverty in Turkey.
- We prepared an information note aimed at the call of the Working Group on Discrimination against Women and Girls of the United Nations High Commissioner of the Human Rights.



SOCIAL WORK AND EMPOWERMENT

Sixty women from three different neighborhoods were selected to work closely within the scope of the Project for the Holistic Support of Women Living in Deep Poverty and Single Parenting. In addition to the monthly in-kind support, we carried out the referral and follow-up processes by developing a social service plan for the needs of social workers and individuals.

Needs Detection:

The priority agendas that emerged within the scope of the talks: Uneasy relationship, divorce process, temporary protection, violence, debt/execution/foreclosure, risk of dropping out of school, relatives of convicts, health problems, malnutrition, housing, substance use history, disability, old age, and lack of identity.

Redirects:

According to the needs and priorities of women and children in each household, referrals were made to the following institutions: District Women, Family, and Psychological Counseling Center; Regional Employment Offices; İŞKUR; IMM Directorate for the Disabled; Census Bureau; District Center for the Disabled; SYDV; SHM; SEDEP; NGO; School; Hospital and psychiatric service of the nearest hospital.

Follow-up processes were carried out to learn how the referrals made to the institutions mentioned above progressed, whether new needs emerged, and to accompany them where needed.

SOCIAL WORK AND EMPOWERMENT

We organized various workshops by organizing meetings with experts on the issues that women need. Simultaneous children's workshops accompanied these workshops.

Meeting workshops: information was given about group dynamics and cohesion, our strengths, and our work methods.

Information such as legal information workshops, obtaining an e-government password, logging into e-government, which documents can be obtained through e-government, and which applications can be made were shared.



Information was given on issues such as debt, enforcement and foreclosure, follow-up of notifications, objection process, hiring a free lawyer, credit card debts, protection from fraud, rent increase, and eviction.

What was done?

Working on our three-year strategy throughout 2022, we created internal policy documents. In this direction, we prepared a Volunteer Rights Policy and Child Safety Policy, In-kind Support Guide, Instruction Guides for Collaborating Institutions, and Cooperation Principles Commitment and received NGO Management Consultancy.

In line with the Transparency and Accountability Principle we have adopted, we have published the In-kind Support Guidelines to convey the in-kind support process, which is carried out by considering ethical values, to the donors and institutions.

We have prepared the "Instruction Guides and Cooperation Principles Commitment for Collaborating Institutions," intending to put into practice the works we carry out with the institutions we cooperate with that directly or indirectly affect people living in poverty, following human rights standards.

RESOURCE DEVELOPMENT

What was done?

To contribute to the sustainability of our activities, various independent artists opened exhibitions, musicians organized concerts, schools organized bazaars, and multiple writers and speakers donated their seminar income and royalties.

We covered human resources, administrative expenses, and project expenses with grants from Heinrichböll Stiftung Turkey Representative, Civil Society Support Foundation, and Suna and İnan Kırac Foundation.

CORPORATE COLLABORATIONS

NEEDS MAP

The database, scheduled with the voluntary technical support of İhtiyaç Haritası, enables us to analyze the extent of poverty experienced by the people included in the Deep Poverty Network and to follow the support and guidance provided easily.

In addition to demographic information, the database includes questions on access to fundamental rights. An inclusive data gathering and needs assessment phase is carried out with criteria such as people's access to clean drinking water, whether people have chronic diseases, whether there is an adult in the household who can read and write, whether there is a child in the household who is disconnected or likely to be disconnected from education, the reasons why the child in the household cannot continue education, and the presence of a woman at risk of early marriage, and whether there is a woman who is in divorce process and in need for support.

CORPORATE COLLABORATIONS

ÖZYEĞİN UNIVERSITY

With the program designed by Özyeğin University Law Clinics Coordinator Lawyer Selmin Cansu Demir, law students will form groups on distinguishing topics with the support of mentor lawyers and the supervision of Selmin Cansu Demir and provide information to households in need of legal advice.

Within the scope of the joint work, we made orientations to the students where we talked about deep poverty, the relationship between poverty and human rights, and case examples of the needs we frequently encounter.

An Information Note on Rent Increase Rates, one of the most prioritized issues in 2022, was prepared, and households experiencing unfair rent increases were informed.

This protocol we signed with Özyeğin University Law Clinics will continue for three years.

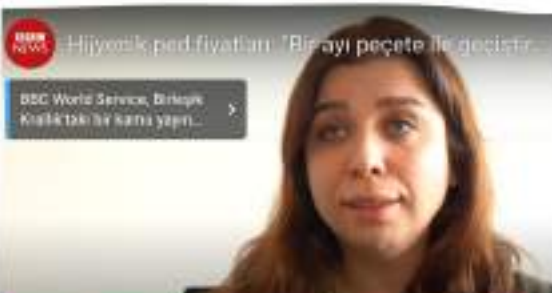

FINANCIAL STATUS

2022* revenues;

79.77% from donations (87.79% from individuals, 6.35% from corporate, 5.86% from in-kind donations)

13.83% from Grant Revenues (76.74% from domestic, 24.26% from overseas grant revenues), 6.40% consists of Other Income (interest income, tax returns, etc.).

2022* expenses

69.8% from Purpose-Oriented Expenses (in-kind support, rent, invoice, drug support, etc.), 25.7% from Personnel Expenses, 4.5% consists of General Administrative Expenses (office rent, invoices, operator, field expenses).
